

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorization**ⁱ

2. **Minimum Need:**

The Office of the People's Counsel requests the services of Blueprint Consulting Services for the meter overage for Xerox V80, two 4110's, and WorkCentre 7225i.

3. **Estimated Fair and Reasonable Price:**

\$30,000.00

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel "OPC" is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Blueprint Consulting Services has been secured for the overage printing on four Xerox machines.
- C. BCS is a District of Columbia government certified small business enterprise. We have consistently worked with Blueprint and they know the operations of the office. With the time restraints Blueprint will be able to provide timely service.
- D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Blueprint Consulting Services.

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Services Date Change, and Public Service Commission Independent Procurement Authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code § 1-1181 et seq.

DC Law: 34-804, hereby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
