1. **Authorization**<sup>i</sup>

2. **Minimum Need:**

The Office of the People’s Counsel requests the services of Superior Couriers to provide reliable messenger services.

3. **Estimated Fair and Reasonable Price:**

\$10,000.00

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel “OPC” is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Superior Couriers is a leading messenger service in express delivery, known for its affordability and reliability. Its service quality distinctly serves OPC’s needs to deliver and transport its publications, legal and other specialized documents to specified locations.
- C. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Superior Couriers.

Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
