

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorizationⁱ**

2. **Minimum Need:**

The Office of the People's Counsel (OPC) requests the services of Veritas Consulting Group, a District of Columbia based electronic security and IT communications technology company specializing in the design, deployment, and sustainment of complex integration systems for new construction and renovation projects.

3. **Estimated Fair and Reasonable Price:**

\$60,690

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Veritas Consulting Group, a District of Columbia based electronic security and IT communications technology company specializing in the design, deployment, and sustainment of complex integration systems for new construction and renovation projects.
- C. Veritas Consulting Group has been procured by the District of Columbia Government's Department of General Services (DGS) to provide audio-visual equipment for installation of said equipment in OPC's new office suite which is currently being constructed.
- D. OPC desires to procure add alternate audio-visual equipment from Veritas Consulting Group to be installed in OPC's new office suite simultaneous to

the DGS installed audio-visual equipment thereby maintaining the installation and service integrity of the procured audio-visual equipment.

E. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Veritas Consulting Group.

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, hereby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
