

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorizationⁱ**

2. **Minimum Need:**

The Office of the People's Counsel (OPC) requests the services of Leidos Digital Solutions, Inc. (Leidos) for Intranet Quorum (IQ) Enterprise Support and Software Maintenance.

3. **Estimated Fair and Reasonable Price:**

\$4,570

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Leidos Digital Solutions, Inc. is a national leader in the integration and application of information technology.
- C. OPC procured a proprietary software developed, owned and copyrighted by Leidos Digital Solutions, Inc. for the purpose of providing utility complaint management solutions. Leidos Digital Solutions, Inc. provides maintenance for said software.
- D. Given the proprietary nature of the software Leidos is the sole vendor authorized to provide IQ enterprise support and software maintenance.
- E. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Leidos Digital Solutions, Inc.

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
