

**DETERMINATION AND FINDINGS  
FOR  
SOLE SOURCE PROCUREMENT**

1. **Authorization<sup>i</sup>**

- 15 DCMR: §3700

2. **Minimum Need:**

The Office of the People’s (“OPC”) Counsel proposes to procure the services of Iron Mountain for off-site storage, cataloging and maintenance of agency and legal files and records for fiscal year 2023.

3. **Estimated Fair and Reasonable Price:**

\$ 8,500

4. **Facts That Justify a Sole Source Procurement:**

- A. OPC is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Iron Mountain is a national company dedicated to storing, protecting and managing, information and assets.
- C. OPC currently utilizes Iron Mountain for its off-site storage, cataloging and maintenance of agency and legal files and records and desires to maintain continuity in the process.
- D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Iron Mountain for fiscal year 2023.

Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
