### 4. Facts That Justify a Sole Source Procurement:

- A. The Office of the People's Counsel is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Strategic Educational Consulting, LLC provides is a minority-owned CBE that provides a wide range of risk assessment, emergency planning, response, and training services to help government agencies, companies, and organizations keep their staff, customers, and clients safe.
- C. OPC has previously worked with Strategic Educational Consulting, LLC to emergency and COOP consultation and training.
- D. Strategic Educational Consulting, LLC has experience with OPC's existing COOP and emergency management plan which will provide them the knowledge required to update the agency's current plan within the desired time period.
