

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorization**ⁱ

2. **Minimum Need:**

The Office of the People’s Counsel proposes to procure the services of The DNA Group to provide professional IT services to implement Office 365 E3, Microsoft Teams Audio Conferencing, Enterprise Mobility and E3.

3. **Estimated Fair and Reasonable Price:**

\$ 34,245

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel “OPC” is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. The DNA Group is a District of Columbia government certified small business enterprise. OPC no longer does business with its previous Office 365 E3, Microsoft Teams Audio Conferencing, Enterprise Mobility and E3 CBE vendor and needs immediate Office 365 E3, Microsoft Teams Audio Conferencing, Enterprise Mobility and E3 services.
- C. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to The DNA Group.

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
