District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Rivendell International Inc. is a District of Columbia based CBE consulting firm providing media consultation, website services, electronic media strategy, contact data analysis and third-party coordination.
- C. Rivendell International Inc. has provided consultation services including, but not limited to, photography, website development, website hosting, website technical support, back-office process training and general administrative support in connection with OPC's website.
- D. Rivendell International Inc. has institutional knowledge of OPC's website structure, mandatory prerequisites, and data integration requirements.
- E. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Rivendell International Inc.
