On April 22, 1970, the world stood up in defense of the environment, and Earth Day was born. On the first DC Earth Day, I remember joining the march to



the Washington Monument, and listening to speakers stress the urgency to save our planet. The observance was the launching pad for a citizen movement that produced new environmental laws and public investments to reduce air pollution, protect nature, and clean our water. For 2024, the theme is "Planet vs. Plastics," and the focus is on reducing plastic production by 60% by 2040.

According to **EarthDay.org**, the goals are to: (1) promote widespread public awareness of the damage done by plastic and demand more research on its impact on public health; (2) rapidly phase out all single-use plastics by 2030 and achieve this commitment in the United Nations Treaty on Plastic Pollution in 2024; (3) demand policies ending the production of some clothing that use a vast amount of plastic; and (4) invest in innovative technologies and materials to build a plastic-free world.

In a column in The Washington Informer Newspaper's annual <u>Earth Day</u> special supplement, I shared some information on plastic waste and its harmful effects on the water supply and water utilities. These impacts can contribute to increased utility costs that consumers ultimately pay.

### OPC Recognized for Language Access Achievement

At a celebration of the 20th anniversary of the passage of the DC Language Access Act on April 24, People's Counsel Sandra Mattavous-Frye accepted the "Most Consistent Agency Award," which the DC Office of Human Rights presented to OPC, for outstanding language access

compliance for three consecutive years.

The anniversary event honored DC agencies and language access advocates who have contributed to the successful implementation of the law. It was adopted to end linguistic barriers for DC residents, workers, and visitors seeking government services and obtain free translation and interpretation services in their respective languages.

Silvia Garrick, OPC's Language Access Coordinator, has been instrumental in guiding OPC's outreach to limited and non-English proficient utility consumers. People's Counsel Frye commented that OPC has complied with the act from the beginning, and our dedicated staff has embraced the opportunity to serve the LEP/NEP community.

"Utility service is an entitlement, and not having service can result in life or death consequences. It has been my goal that no District resident ever be denied service or have their rights limited because of a language barrier. OPC will keep moving forward in our efforts to serve all of the residents of the District of Columbia no matter their language or ethnicity," she stated.

# A Win in OPC's Corner as the Pepco Rate Case Proceeds



OPC is keeping you up to date on the proceedings related to Pepco's application to implement a

multiyear rate plan which will affect the way your rates are increased.

On April 1, the Public Service Commission issued a decision (order 21976) in favor of an OPC request. OPC sought modifications to the procedural schedule for the PSC's consideration of Pepco's application. OPC argued that the schedule should be modified to include a deadline for Pepco to provide responses to OPC's request for data from Pepco. Furthermore, OPC and other parties to the case asserted that they would need more time to incorporate Pepco's responses into their subsequent testimony.

Pepco opposed OPC's motion. However, the Commission disagreed with the utility, stating that OPC presented good reasons why the procedural schedule should be adjusted to establish a deadline for Pepco to provide responses and more time for OPC and other parties to review and respond in future testimony.

In case you missed it, the Commission recently held three public hearings to hear from consumers. People's Counsel Sandra Mattavous-Frye stepped up to the podium to speak at the final one on April 3. Among other points, she called on consumers to educate themselves on the rate increase case, consider all sides, and recognize that Pepco has an obligation to be a good corporate partner with no strings attached. More than 80 individuals from across the social service spectrum attended, including representatives from DC Council offices, Pepco, Washington Gas, DC Water, and the Department of Energy & Environment. Speakers shared insightful information and tools consumers can use to keep the lights on and the water running.


Rachelle P. Nigro, Pepco's Senior Community Relations Specialist, stressed the need for consumers to reach out to Pepco's customer service before they are disconnected so that the utility can try to address their needs. For example, if a resident has a medical issue, contact Pepco to have that information placed on file, she said.

DeShandra Jones, Washington Gas Senior Director of Billing, Collections, and Digital Experience, advised consumers to reach out to the company for assistance with payment plans, which can be extended up to 24 months in certain situations.

Meisha Thomas, DC Water Director of Customer Care, discussed the disconnection process, when liens can be placed on a property, and bill payment assistance.

Sharon Y. Cooke, DOEE Energy Assistance Center Supervisor, provided a comprehensive overview of the application process for Low Income Heating Energy Assistance/LIHEAP and the Utility Discount Program. According to Cooke, many residents are eligible for the programs but are not taking advantage of them. Applications can be completed at <a href="mailto:doee.dc.gov">doee.dc.gov</a>.

In addition, OPC staff led breakout sessions where attendees were able to ask the speakers questions to get more information. 



For example, if a resident has a medical issue, contact Pepco to have that information placed on file, she said.

DeShandra Jones, Washington Gas Senior Director of Billing, Collections, and Digital Experience, advised consumers to reach out to the company for assistance with payment plans, which can be extended up to 24 months in certain situations.

Meisha Thomas, DC Water Director of Customer Care, discussed the disconnection process, when liens can be placed on a property, and bill payment assistance.

Sharon Y. Cooke, DOEE Energy Assistance Center Supervisor, provided a comprehensive overview of the application process for Low Income Heating Energy Assistance/LIHEAP and the Utility Discount Program. 



Nigro, Pepco's Senior Community Relations Specialist, stressed the need for consumers to reach out to Pepco's customer service before they are disconnected so that the utility can try to address their needs. For example, if a resident has a medical issue, contact Pepco to have that information placed on file, she said.

DeShandra Jones, Washington Gas Senior Director of Billing, Collections, and Digital Experience, advised consumers to reach out to the company for assistance with payment plans, which can be extended up to 24 months in certain situations.

Meisha Thomas, DC Water Director of Customer Care, discussed the disconnection process, when liens can be placed on a property, and bill payment assistance.

Sharon Y. Cooke, DOEE Energy Assistance Center Supervisor, provided a comprehensive overview of the application process for Low Income Heating Energy Assistance/LIHEAP and the Utility Discount Program. 



#### Planet vs. Plastics

On April 22, 1970, the world stood up in defense of the environment, and Earth Day was born. On the first DC Earth Day, I remember joining the march to



the Washington Monument, and listening to speakers stress the urgency to save our planet. The observance was the launching pad for a citizen movement that produced new environmental laws and public investments to reduce air pollution, protect nature, and clean our water. For 2024, the theme is "Planet vs. Plastics," and the focus is on reducing plastic production by 60% by 2040.

According to **EarthDay.org**, the goals are to: (1) promote widespread public awareness of the damage done by plastic and demand more research on its impact on public health; (2) rapidly phase out all single-use plastics by 2030 and achieve this commitment in the United Nations Treaty on Plastic Pollution in 2024; (3) demand policies ending the production of some clothing that use a vast amount of plastic; and (4) invest in innovative technologies and materials to build a plastic-free world.

In a column in The Washington Informer Newspaper's annual <u>Earth Day</u> special supplement, I shared some information on plastic waste and its harmful effects on the water supply and water utilities. These impacts can contribute to increased utility costs that consumers ultimately pay.


Rachelle P. Nigro, Pepco's Senior Community Relations Specialist, stressed the need for consumers to reach out to Pepco's customer service before they are disconnected so that the utility can try to address their needs. For example, if a resident has a medical issue, contact Pepco to have that information placed on file, she said.

DeShandra Jones, Washington Gas Senior Director of Billing, Collections, and Digital Experience, advised consumers to reach out to the company for assistance with payment plans, which can be extended up to 24 months in certain situations.

Meisha Thomas, DC Water Director of Customer Care, discussed the disconnection process, when liens can be placed on a property, and bill payment assistance.

Sharon Y. Cooke, DOEE Energy Assistance Center Supervisor, provided a comprehensive overview of the application process for Low Income Heating Energy Assistance/LIHEAP and the Utility Discount Program. According to Cooke, many residents are eligible for the programs but are not taking advantage of them. Applications can be completed at <a href="mailto:doee.dc.gov">doee.dc.gov</a>.





# A Note from Your People's Counsel Sandra Mattavous-Frye

### Planet vs. Plastics

On April 22, 1970, the world stood up in defense of the environment, and Earth Day was born. On the first DC Earth Day, I remember joining the march to



the Washington Monument, and listening to speakers stress the urgency to save our planet. The observance was the launching pad for a citizen movement that produced new environmental laws and public investments to reduce air pollution, protect nature, and clean our water. For 2024, the theme is "Planet vs. Plastics," and the focus is on reducing plastic production by 60% by 2040.

According to **EarthDay.org**, the goals are to: (1) promote widespread public awareness of the damage done by plastic and demand more research on its impact on public health; (2) rapidly phase out all single-use plastics by 2030 and achieve this commitment in the United Nations Treaty on Plastic Pollution in 2024; (3) demand policies ending the production of some clothing that use a vast amount of plastic; and (4) invest in innovative technologies and materials to build a plastic-free world.

In a column in The Washington Informer Newspaper's annual <u>Earth Day</u> special supplement, I shared some information on plastic waste and its harmful effects on the water supply and water utilities. These impacts can contribute to increased utility costs that consumers ultimately pay.

Earth Day should move all of us to do our part every day to save natural resources. Will you start by considering cutting back on single-use water bottles, a top source of water pollution? OPC is committed to working with stakeholders year-round to raise awareness and advocate for policies that ensure safe and clean water for District residents.

"Utility service is an entitlement, and not having service can result in life or death consequences. It has been my goal that no District resident ever be denied service or have their rights limited because of a language barrier. OPC will keep moving forward in our efforts to serve all of the residents of the District of Columbia no matter their language or ethnicity," she stated.

# A Win in OPC's Corner as the Pepco Rate Case Proceeds



OPC is keeping you up to date on the proceedings related to Pepco's application to implement a

multiyear rate plan which will affect the way your rates are increased.

On April 1, the Public Service Commission issued a decision (order 21976) in favor of an OPC request. OPC sought modifications to the procedural schedule for the PSC's consideration of Pepco's application. OPC argued that the schedule should be modified to include a deadline for Pepco to provide responses to OPC's request for data from Pepco. Furthermore, OPC and other parties to the case asserted that they would need more time to incorporate Pepco's responses into their subsequent testimony.

Pepco opposed OPC's motion. However, the Commission disagreed with the utility, stating that OPC presented good reasons why the procedural schedule should be adjusted to establish a deadline for Pepco to provide responses and more time for OPC and other parties to review and respond in future testimony.

In case you missed it, the Commission recently held three public hearings to hear from consumers. People's Counsel Sandra Mattavous-Frye stepped up to the podium to speak at the final one on April 3. Among other points, she called on consumers to educate themselves on the rate increase case, consider all sides, and recognize that Pepco has an obligation to be a good corporate partner with no strings attached. 


