# 1. **Authorization**<sup>i</sup>

# 2. **Minimum Need**

The Office of the People's Counsel for the District of Columbia ("OPC" or "Office") requests the services of Spiegel & McDiarmid, who have experience in legal consulting services in the area of public utility in Federal Energy Regulatory Commission (FERC) proceedings seeking modifications to the rules governing the conduct of PJM's Base Residual Auctions (BRA) for capacity.

#### 3. Estimated Fair and Reasonable Price

The total contract not-to-exceed price is \$40,000.

#### 4. Facts That Justify a Sole Source Procurement

- A. The Office of the People's Counsel for the District of Columbia is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Spiegel & McDiarmid will respond in opposition to the "Stipulation/Joint Motion to Dismiss" in the PA Governor's complaint against PJM (Docket No. EL25-46), along with respond in opposition to PJM's February 24 "answer to Complainant's motion for leave to answer" and renewed request that FERC dismiss the complaint, filed in the JCA complaint docket, No. EL25-18 and respond in opposition to PJM's FPA section 205 "price collar" filing in Docket No. ER25-1357.
