# DETERMINATION AND FINDINGS FOR SOLE SOURCE PROCUREMENT

## 1. <u>Authorization</u><sup>i</sup>

#### 2. **Minimum Need**

The Office of the People's Counsel for the District of Columbia ("OPC" or "Office") requests the services of Acadian Consulting Group ("ACG"), which has considerable empirical expertise and regulatory experience in technical consulting services. ACG will provide expert assistance in developing a peer review of an upcoming study prepared for OPC by Synapse Energy Economics.

#### 3. <u>Estimated Fair and Reasonable Price</u>

The total contract not-to-exceed price is \$10,000.

### 4. Facts That Justify a Sole Source Procurement

- A. The Office of the People's Counsel for the District of Columbia is an independent agency of the District of Columbia government. By law, it advocates for consumers of natural gas, electric, and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Acadian Consulting Group will fully review the upcoming Synapse Energy Economics' Affordability Analysis study, including a general review of workpapers supporting the analysis, presuming these will be available. ACG will summarize the review in written form, using a PowerPoint summary analysis, complete with citations and comparisons to other comparable studies in regulation and academia. ACG will prepare a virtual meeting with OPC staff and the Directorate to discuss and explain their findings.
